SUPPLEMENTARY REGULATIONS

- 1. The Maidstone & Mid Kent Motor Club Limited will promote a Clubsport status Multi venue All forwards Autotest starting at Headcorn Aerodrome, Kent. (MR 188/848829) on Sunday 22nd July 2012.
- 2. The meeting will be held under the General Regulations of the Motor Sports Association Limited (incorporating the provisions of the International Sporting Code of the FIA), these supplementary regulations and any written instructions that the organising club may issue for the event.

- 4. The events are open to all fully elected members of the organising club, and the following invited clubs:-Weald Motor Club, and the Historic Rally Car Register
- 5. All competitors must produce for inspection at signing-on, a valid Club Membership Card for the event.
- 6. The programme of the meeting will be as follows:-
 - Signing starts at 08.30 a.m. followed immediately by Scrutineering.
 - Any competitor not signed on by 09.30 a.m. may be excluded
 - The event will start at 10.00 a.m.
 - Finish BARBECUE (included in entry fee) 5.00pm (approx)
- 7. The event will consist of seven classes as follows:
 - A. Front wheel drive Touring Cars up to and including 3.66m (12ft) overall length
 - B. Front wheel drive Touring Cars over 3.66m (12ft) and under $4.1m (13' 5\frac{3}{4}")$ overall length
 - C. Front wheel drive Touring Cars 4.1m (13'-5³/₄") and over, and Four-wheel drive Series Production Touring cars.
 - D. Rear wheel drive Touring Cars and all Sports Cars.
 - E. Specials.
 - F. Historics, cars registered before 1 January 1981.
 - J. Production Car Autotest, for Junior Drivers. Aged 14 to 17 who do not hold a full RTA Licence. (See below for Supplementary Regulations.) All vehicles competing in this class must be by definition "a Touring Car". Whilst competing, one passenger must be carried in each car, who holds a full RTA Licence is a full member of one of the above named clubs and is experienced in Autotesting.

All vehicle lengths will be taken as stated in the "Parkers Car Price Guide" or, if not quoted, the manufacturers specification.

8. All vehicles must comply with the 2012 MSA Vehicle regulations. All vehicles must be taxed and insured for the public highway and must have current tax disc, current insurance certificate and current VT20 MOT certificate unless less than 3 years old from the date of first registration. Proof of date of registration will be required if the vehicle has no VT20. Vehicles must be presented to scrutineering and start with road legal tyres ie ;minimum 1.6mm tread depth. Tyres changed during the event must be approved by the Clerk of the Course or Scrutineer. Vehicles will be strictly scrutineered and all documents checked. Classification of any vehicle will be entirely at the discretion of the organisers. Cars may be trailered to and from the event but must **be driven** between the competitive venues. In the case of Class J, the car must be driven by the passenger on the public highway between venues.

- Awards will be presented at each event as follows:-
 - FTD First in each class Second in each class Third in each class

Other awards may be given at the organiser's discretion. No competitor may win more than one award.

- 10. Competitors will be identified by numbered time cards, which will be issued by the organisers.
- The entry list opens on publication of these regulations and closes finally on Monday 16 July. All entries must be made on the official entry form and accompanied by the appropriate fee as follows: The entry fee is £25.Entry fees may be refunded at the organisers discretion. Late entries may be accepted at the organisers discretion and subject to a fee of £35.

The maximum entry for each event is 50, and the minimum is 20. The maximum for each class is unlimited, and the minimum is 1. Should any of the above minimum figures not be reached, the venues be too wet or the venues not be available, the organisers have the right to cancel the meeting or amalgamate classes as necessary. Entries will be selected in order of receipt. Final instructions will be issued on the day , before the start of the event , giving test diagrams and venue locations. There will be no set route between the venues. Estimated total mileage is 50 miles. A scanned map will be given showing the location of the venues but if you wish to bring your own you need Map 189.

- 14. Details of tests for the event will be issued at signing on. Each driver will have two runs at each test, with only the drivers best run at each test to count towards results. Timing for all classes will be by hand held watches, timed to 0.1 seconds (M.15). The starting signal will be oral. Order of attempting tests will be as directed by the organisers. Practising will not be allowed. All marshals will be judges to adjudicate on penalties (M.8).
- 15. Provisional results will be published as soon as possible following the end of each event.
- 16. Any protests must be lodged in accordance with MSA Yearbook Judicial (C) Protests.
- 17. All other General Regulations of the MSA apply as written except the following which are modified:-
 - (H) 35.1.4 A Novice is defined as a driver who prior to 01-01-2012 has not won an award, other than Best Novice at an Autotest.
 - (M) 13.4 For the event a vehicle may not be entered to compete for the same award more than twice, to be driven by different drivers, but no driver may enter more than once. The number of drivers for any one vehicle is limited to three
 - (M) 17.2 Light commercial vehicles are accepted and will be treated as Touring Cars
 - (M) 27.4 Marking and Penalties will be as printed in Table M.7 except where amended as follows for all classes:-

(c)	"Not performing a test correctly, etc."	+30 seconds
(d)	"Striking any pylon, etc. per mistake"	+10 seconds
(e)	"Failing to cross or stop at any line etc."	+10 seconds
(f)	"Every second (& fraction) to complete test	1 & fraction

CLASS J, for JUNIOR DRIVERS.

SUPPLEMENTARY REGULATIONS

Our successful **Class J** for "*Junior Drivers*", will be run under MSA specific regulations for a **Production Car Autotest** as follows:-

- 1. All *Junior Drivers* must be 14, 15, 16, or 17 and not hold a full RTA Driving Licence.
- 2. **AT ALL TIMES** each *Junior Driver* must carry **one passenger** in the car, who may assist in giving directions to the driver, holds a full RTA Driving Licence and is experienced in autotesting .
- 3. Both Driver and Passenger must be a member of Maidstone and Mid Kent Motor Club or one of the invited clubs, and sign on as appropriate.
- 4. The passenger must occupy the seat alongside the driver and **wear a properly fastened approved seat belt** at all times during the test.
- 5. All vehicles in this Class must be by definition a **touring car.** They do not have to be driven to the event, however, they must comply with MSA Vehicle Regulations and pass scrutineering at the event. This definition means that sports cars and cabriolet vehicles cannot be used.
- 6. The tests will be the same as the main event, and only a drivers best time at each test will count towards results.
 - Tests will be timed to 1/10 second
 - Penalty for touching a course marker 10 seconds
 - Penalty for a wrong test 30 seconds plus the fastest time in Class J for that test.
