SUPPLEMENTARY REGULATIONS

1. The Maidstone & Mid Kent Motor Club Limited will promote a Clubmans Autosolo and a Clubmans All Forward Autotest on Saturday 8th June 2014 at Sittingbourne Stadium, Sittingbourne, Kent, ME10 3SB. The event will be open to all fully elected members of the organising club, the members of the Weald Motor Club. Entry is also open to members of other MSA registered clubs not previously mentioned up to the maximum of 15 on a first come first served basis.
2. The meeting will be held under the General Regulations of The Motor Sports Association Limited (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions the organising club may issue for the Event.
3. The MSA Clubmans Autosolo Permit No 83546
The MSA Clubmans Autotest Permit No 83547
4. Club membership cards will be inspected at Signing-on.
5. The event will take place at Central Park Stadium, Church Road, Eurolink, Sittingbourne, Kent, ME10 3SB. The event will take place entirely on Private Land. There will be at least 2 tests and it is hoped that at least 3 runs will be allowed at each test. The two best runs on each test will count for the awards.
6. Signing-on will commence at 08:30 hours, followed immediately by Scrutineering. The Event will start at 10.00 hours. Any competitor who has not signed on by 09.30 hours may be excluded.
7. The following classes will apply:

Class A : Series Production Cars – Saloons/estates up to 1400cc

Class B : Series Production Cars - Saloons/estates 1401cc to 1800cc

Class C : Series Production Cars - Saloons/estates over 1801cc.

Class D : Series Production Sports Cars – including MX5, Lotus Elise, Vauxhall VX220 etc.

Class E : Specialist Cars not eligible for classes A to D, including Caterham, Westfield, etc.

Class F : Historic's, Cars registered before 1st January 1981.

An all forward Clubmans Autotest

Class G: All cars will compete as one class to a maximum of 15 cars. Cars in this class may be trailered to the event.

Petrol engined cars with forced induction in classes A and B will move up one class capacity. Rotary engined cars will be classed at 1.5 times their nominal capacity. Diesel engine cars with or without forced induction will run in the class corresponding to their engine capacity.

In Classes A to D cars must retain the original panel, window materials, have full trim and seats, although the type may be changed. Also in Classes A to D the engine must be of original manufacture and original basic type and must be fitted in the original position. The engine may be modified and may be of different capacity provided that the car is entered in the class corresponding to the actual engine capacity. Cars not meeting these requirements are eligible for Class E only.

8. All cars must comply with the 2013 MSA Vehicle Regulations. All vehicles must be taxed and insured for the public highway, (except Class G) and **MUST be driven to the event on the public highway**. All competing vehicles must have, current Tax Disc, a current insurance certificate and a current VT20 MOT certificate unless less than three years old from their date of first registration. Proof of date of registration will be required if the vehicle has no VT20. Vehicles must be presented to scrutineering and **start with road legal tyres)i.e. minimum 1.6mm tread depth)**. Tyres changed during the event, must be approved by the Clerk of the Course. **Tyres from List 1B are not permitted**.
 9. Vehicles will be strictly scrutineered. Documentation will be checked (MSA GR M33). Classification of any vehicle will be entirely at the discretion of the organisers.
 10. Awards will be presented as follows:
 - First Overall (least total of penalties).
 - First in each Class.
 - Second in each Class, subject to five entries
 - Third in each class, subject to eight entries
 - Classes with less than two entries may be amalgamated at the organiser's discretion.
 - (No Competitor may win more than one award)
 11. The entry list opens on publication of these Supplementary Regulations and closes on **Monday 2nd June 2014**. The entry fee is **£35.00 reduced to £25.00 if received by 27th May**. All entries must be made on the official entry form and be accompanied by the appropriate fee. Entry fees may be refunded at the organisers' discretion. Late entries **WILL NOT** be accepted.

Should the event be oversubscribed a list of five reserves will be held. A maximum of two (at the organiser's discretion) drivers per car will be accepted, each being treated as a separate entry. Final instructions will be made available to entrants before the start of the competition. Entries will be accepted on a first come first served basis.
 14. Penalties will be as MSA GR M7 and M26 as printed.
 15. Provisional results will be published as soon as possible following the end of the event. Protests must be made in accordance with MSA GR C5.2.
 16. Identification numbers will be supplied by the organisers and must be fixed in a prominent forward facing position.
 17. All marshals are appointed "Judges of Fact" to adjudicate on items listed under GR M26.
