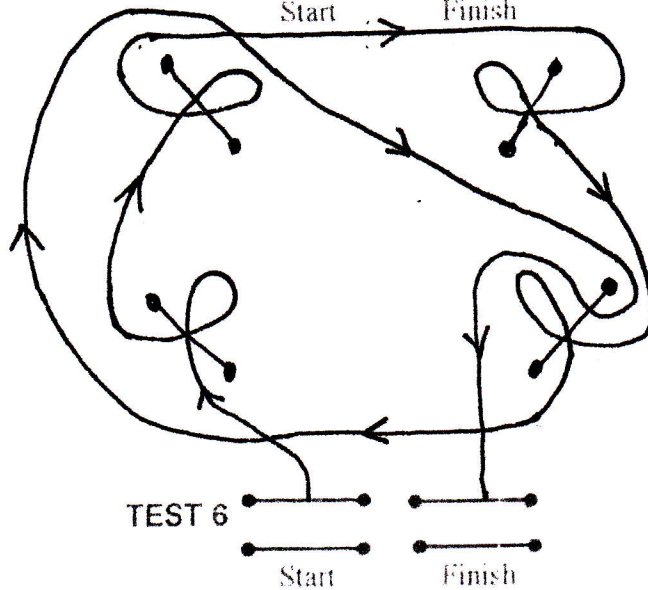
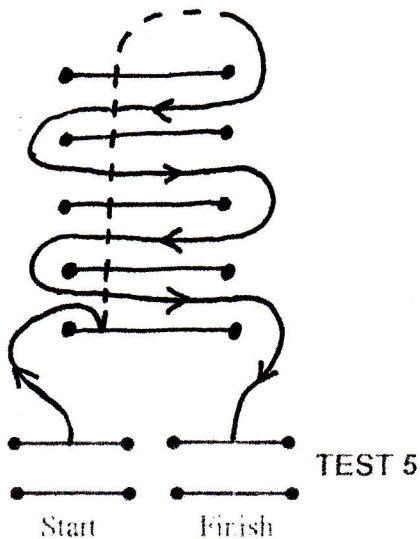
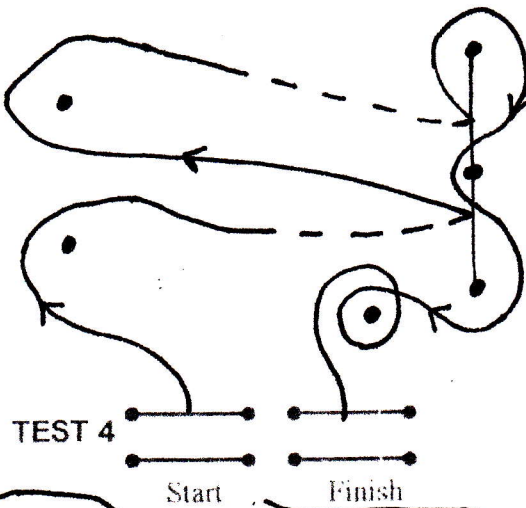
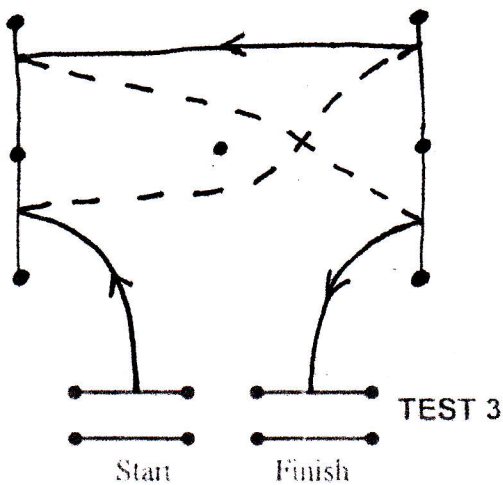
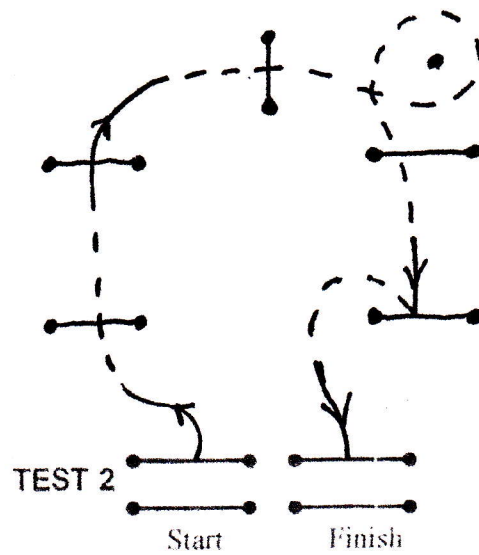
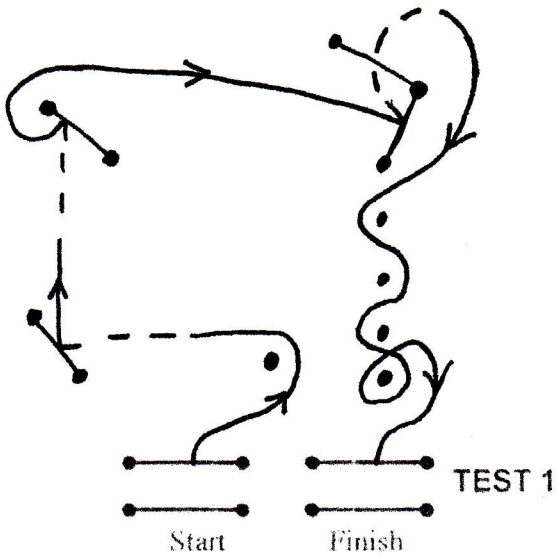


Start
